1. PURPOSE

This paper gives an overview of Dorset LEP programme delivery. It is accompanied by several annexes, which are all classified as confidential due to containing commercially sensitive information:

A) GETTING BUILDING FUND (GBF)

Annex 2 provides a high-level overview of Local Growth Fund and Getting Building Fund projects; outlining risks and progress.

GETTING BUILDING FUND - PROGRAMME AND FINANCIAL UPDATE

The Getting Building Fund Programme actual spend to date is £8m. The Q3 spend was £2.9m, against £3.1m forecast.

Five projects have now fully spent their GBF funding and delivered most of their outputs.

£5.6m of match funding has been delivered to date and over £10m of match funding is forecasted to be delivered post March 2022.

B) LOCAL GROWTH FUND (LGF)

Annex 2 provides a high-level overview of Local Growth Fund and Getting Building Fund projects; outlining risks and progress.

DORSET LOCAL GROWTH FUND - PROGRAMME AND FINANCIAL UPDATE

The delivery of outcomes and match funding continues to be monitored and reported until March 2025. There has been some changes and minor delays projected in outcome delivery mainly due to Covid-19. There has been increase in houses and apprenticeships forecast and decrease in new learners. The overall Programme delivery of outcomes is on track.

The reporting is bi-annual and as of Q2, £62m of match funding has been delivered, with further £11.8m to be delivered up to March 2025. These will be updated for Q4 reporting.

As of Q2, the LGF Programme has delivered the following outcomes:

- 2.538 houses
- 3,205 jobs (including safeguarded jobs)
- 3,357 apprenticeships
- 15,305 sqm of learning floorspace
- 90,177 sqm commercial floorspace
- 54 businesses supported
- 20.5 km of road resurfaced
- 3.5 km of newly built road
- 11.1 km

C) DORSET GROWING PLACES FUND (GPF)

Annexes 3 and 4 provide high level overview of Growing Places Fund projects.

To date, the Fund has invested into 13 projects, 12 of which are loans and 1 is a grant. As of today, 7 projects are complete with loans repaid. There are currently 5 outstanding loans.

D) UPDATE ON ONGOING DORSET GATEWAY PROJECTS

Dorset Gateway has funding linked to delivery targets or specific contracts. An overview of performance to date in these areas is provided below.

Enquiry management

An overview of business engagements recorded for the period between 1 April 2018 and 31 January 2022 is presented below in *figure 1*. The targets have been agreed with the Department for Business Energy and Industrial Strategy (BEIS) and are reflected in the delivery contracts issued to partners. These figures do not include any enquiries relating to Peer Networks as these are captured elsewhere.

All figures are subject to ongoing audit checks via our customer relationship management (CRM) tool. Figures are cumulative based on the number of hours support that each business or individual receives. The large number of medium intensity assists reflects the increase in Dorset Gateway delivered events (such as workshops and masterclasses) as well as the increased number of customer facing staff available to provide business support.

As figures are cumulative, it is normal for high intensity interactions to be lower at the start of the year. As businesses engage over the course of the year, then the number of hours they spend accessing business support programmes increase. 'High Intensity' engagements are marginally lower than we would have projected at this stage but there are several programmes concluding as well as events over the next two months. As a result, we are confident that we will comfortably reach the High Intensity engagements target by 31 March 2022.

An updated table, to include February, will be provided at the meeting.

Peer Networks Programme

February saw the launch of our sixteenth Peer Network cohort. This is likely to be our last cohort that we start before the end of the funding period (31 March 2022). We had secured funding to deliver 20 cohorts, but as previously reported, recruitment has proved difficult and there have been some issues with delivery partners, which have now been addressed.

As reported previously, through our contract management arrangements, we took action to try and address the shortfall in November 2021. We are on track to deliver 17 cohorts by the 31 March 2022 which will mean around 190 businesses will have been enrolled onto the programme in 2021, surpassing last year's total of 148 businesses. We have remained in contact with BEIS regarding the projected delivery numbers so that they are aware and there has been a national issue in recruitment for this scheme. As previously advised, the Peer Networks programme will not be continuing in 2022/23.

Back to Business: BCP Council's Bounce Back Challenge Fund

This programme, funded by BCP Council as part of their BCP Futures Campaign, is aimed at helping businesses in the BCP area recover stronger from the impacts of the COVID-19 pandemic. This project officially started at the beginning of September and will conclude by 31 March 2022. With the aim of engaging 100 businesses by 31 March, as of 09 February, we had surpassed that that target, with 110 enquiries received. 41 businesses have completed a business diagnostic and have been signposted to other support, such as Peer Networks, as well as programmes offered by others such as Dorset Growth Hub. Seven enquiries have so far been assessed and referred for further funded support with our delivery partners.



This programme continues to be popular amongst local businesses and feedback so far has been extremely encouraging.

Bid Writing Support Service (BWSS)

The BWSS has continued to work with local SMEs with the aim of helping them to secure innovation and research-based funding.

As reported previously, whilst the number of days support is below target, this is calculated on the amount of time we are invoiced for by our bid writing specialist. As the service has become more established, we have seen more established and experienced businesses coming forward for support. This has meant that we are spending less time of their applications prior to submission as they typically require less support. Whilst we have seen a reduction in the time spent with each business, we have had an increase in outputs, with the number of grant applications submitted exceeding our target.

The overall number of businesses engaged has been marked as on target as we have two business facing events taking place in March that we expect to take us past our target number.

The level of customer satisfaction has been actively followed as is reflected in the figures provided. This has also been positively impacted by reaching bid deadlines. We are finalising several user case-studies that we can share across our networks.

Design Innovation Support

Dorset Gateway has partnered with Arts University Bournemouth (AUB) to offer a new, exclusive, consultant and specialist-led innovation and design funding for emerging Dorset businesses. Funded consultancy of up to £5,000 is being made available to sole traders, limited companies and social enterprises registered or operating within Dorset, through this funding. The support provides up to 100 hours of design consultancy from one of three highly regarded Dorset product design and development specialists. The support funded will vary dependent on individual business requirements.

A call for applications was opened in December and closed on 06 January 2022. A total of 18 applications were received and assessed against set criteria which looked at technology readiness levels, routes to market, social impact and carbon reduction. As a result, six applications were identified for further funded support of between £1,500 and £5,000. Several



businesses will also be eligible for additional grant funding through AUB's ERDF (European Regional Development Fund) project.

Applicants whose proposals were not taken forward have been contacted and, where possible and/or appropriate, signposted to other business support programmes more suited to their projects.

E) DORSET INNOVATION PARK (DIP)

Phase 2 of the BattleLab is now complete with a launch event expected to take place in May 2022.

Marketing of the site and work on the website refresh continues.

An event on 10 February 2022 was organised by the Dorset Engineering and Manufacturing Cluster (DEMC) and Dorset LEP will be giving a presentation on the strategic importance of the DIP.

A further event was run by the BattleLab team on 25 February and one is planned for 4 March 2022. As part of these events, members of the Dorset Gateway team will be working alongside the Defence and Security Accelerator's (DASA) <u>Access to Mentoring and Finance (AMF) Team.</u>

Dorset Gateway alongside other members of the Dorset Inward Investment Team will be arranging a visit by colleagues in the Department for International Trade (DIT), to come and see the BattleLab facility and other key strategic defence sites in early Spring 2022.

F) CAREERS AND ENTERPRISE COMPANY (CEC) – CAREERS HUB

Significant analysis of our schools data has highlighted great achievements and trends, combined with weaknesses, which has enabled us to identify focus areas and where there is a need for specific intervention. Some highlights are:

- Middle Schools have emerged as an area where key support is needed and a plan
 has been put into place to overcome current low attainment of targets. We are
 specifically working to improve EA representation and work experience in the cohort,
 which equates to 15% of the schools in our network.
- Our SEND schools also need greater support, and we will focus on engaging the SLT at these institutions to get renewed buy-in and in turn increase opportunities for the students.
- We have reviewed and re-engaged with our Cornerstone Employer Group and Lead Schools and some changes have been made to the members to ensure the support from these key support networks is felt and impact is seen. More new employers will be brought on board to boost the Cornerstone Group.



- T-Levels at Ferndown Upper School were launched, and we are working with Toby Osborne to proactively support their campaign.
- We have recently bid for and been awarded funding for amplification of apprenticeships and technical qualifications which will see us run a research project, conference and a further initiative that aims to change perceptions of apprenticeships amongst key target groups.
- Networking and social media activity has increased significantly which means that
 more people are aware of our presence and work and wanting to contribute and
 support, importantly the number of offers of work experience and EA's.

Other funded skills delivery

Dorset LEP have been working to ensure Dorset residents have opportunities to participate in recovery initiatives, as they become available.

- SAP Programme we have delivered the Local Skills Report within the Department of Education timelines – published 27/1/2022. A range of comms around this is continuing.
- **Skills Boot Camps** we have bid with Somerset County Council for a range of Skills Boot Camps under the wave 3 provision. The full bid is c.£1.5m and will be project managed by Somerset CC. Details of award are expected early in April.
- **Skills Commission** BCP and Dorset Councils have approved funding for a year long Skills Commission to review the Dorset skills landscape in consideration of the Skills White paper, the levelling up agenda and produce a report that lays out a potential skills journey with 10, 20 and 30 years trajectories. The tender for a chair is due to be launched in March.
