E) SKILLS

Careers and Enterprise Company (CEC) - Careers Hub

Delivery of the CEC contract to provide the Dorset Careers Hub continues with the majority of events and school actions in this summer term. The Hub have delivered a variety of events, including Apprenticeship 2.0, Career Leader awards in DC and BCP, inspiration events in partnership with BU and work streams across SEND, middle and primary levels. The summer term delivery within schools was positive and engaging for young people.

As previously reported, Dorset Careers Hub were successful in bidding for a Hub Innovation Project 1 September 2022, to work with businesses specifically to raise awareness and ability to employ SEND young people aged 16-19.

The Dorset Marvels project (CEC funded) has completed its first year and with the annual report due mid-Sept. This project will continue to intensively deliver to vulnerable year 11's in Learning Centres and selected senior schools across Dorset from September 2022.

F) DORSET INNOVATION PARK (DIP)

The Dorset Innovation Park (DIP) Memorandum of Understanding remains in place and since the Dorset Council Cabinet approved a significant £3.1m of investment for the site, plans are underway to develop the business case for the further £11.5m to be approved in 2023/24.
