

# Dorset Local Enterprise Partnership

Staff Conflict of Interest Policy

September 2020

## 1. Registering and declaring pecuniary and non-pecuniary interests

- 1.1. You must, within 28 days of taking office as a Dorset LEP member of staff, notify Dorset LEP's Director of any disclosable pecuniary interest, where the pecuniary interest is yours, your spouse's or civil partner's, or is the pecuniary interest of somebody with whom you are living with as a spouse, or as if you were civil partners.
- 1.2. In addition, you must, within 28 days of taking office, notify your Dorset LEP's Director of any non-pecuniary interest which Dorset LEP has decided should be included in the register or which you consider should be included if you are to fulfil your duty to act in conformity with the Seven Principles of Public Life. These non-pecuniary interests will necessarily include your membership of any Trade Union.
- 1.3. Following any disclosure of an interest not on the Dorset LEP register or the subject of pending notification, you must notify Dorset LEP's Director of the interest within 28 days beginning with the date of disclosure.
- 1.4. Unless dispensation has been granted, you may not participate in any discussion of, or discharge any function related to any matter in which you have a pecuniary interest. Additionally, you must observe the restrictions Dorset LEP places on your involvement in matters where you have a pecuniary or non-pecuniary interest as defined by Dorset LEP.
- 1.5. Please refer to Dorset LEP's Hospitality and Anti-Bribery Policy on the Dorset LEP **website**, for the procedure for declaring and reporting on hospitality.
